Annual Fair Share Commitment

Bet Alef's dues policy is based on the belief that each of us plays an equitable and important role in the support and development of our community. We are a "fair share" congregation, meaning each member household pays its portion of the membership cost based on financial capability.

In order to meet our budget for FY 2008 we need to receive an average of \$1,800 from each of our families. Those of you paying over the average enable us to support those whose resources are less. Dues include the cost of Torah Study, Passover and High Holiday workshops as well as reduced pricing for classes and activities.

Minimum dues are \$550 annually or \$46 per month. As always, every family is warmly welcomed into Bet Alef without regard to income. Please call our office at 206.527.9399 if you are unable to pay minimum membership dues of \$46 per month, or your "fair share" of 1.7% to 2.7% of gross income, as appropriate.
